## **Investment Objective and Policies**

Jadwa Arab Markets Equity Fund, an open-ended equity fund, aims to provide long-term capital growth for unitholders by investing in the Pan Arab equity markets and in shares of Pan Arab companies or any of their subsidiaries listed on any other stock market in accordance with Shariah investment guidelines.

The below summarizes the investment policy.

The Fund aims to invest its assets in any of the following:

- A) Shares of Pan Arab Stock Market-listed companies or of any of their subsidiaries listed on any other stock market;
- B) IPOs, secondary issuances, and rights issues to increase the capital of Pan Arab Companies that are listed or to be listed on the Pan Arab Stock Market, or that are listed or to be listed on any other global market, and any other related financial instruments;
- C) Other similar Pan Arab funds;
- D) Fund Manager may invest all assets in short-term Murabaha agreements in the following cases for example but not limited to:
  - a. Lower performance by Pan Arab Stock Market; and
  - b. Diversification of the Fund's investments to make use of money market returns;
- E) The Fund Manager may reduce the minimum investment in shares of Pan Arab -listed Companies, IPOs, secondary offerings and Rights issues from 30% to 0% in the following cases:
  - a. The financial markets are likely to plunge due to the economic conditions globally or regionally;
  - b. The financial markets likely to plunge due to the poor political conditions globally or regionally;
  - c. Lack of attractive investment opportunities;
  - d. Any reason deemed by the Fund Manager to protect the interest of Investors, which may include the bankruptcy declaration by any leading local company, or a large bank, or in the case of sharp deterioration in any of the regional economies which would directly or indirectly impact Fund investments.





Metric	Description

Alpha	Measures the fund's value added relative to a benchmark.	
Beta	Beta is a measure of a portfolio's volatility in relation to a benchmark.	
Information ratio	A risk-adjusted measure that compares the performance of a fund relative to a benchma compared to the volatility of those returns.	
Sharpe	A risk-adjusted ratio that measures excess return over a risk-free rate relative to the volatility of a given security or fund.
